



HEALTH SERVICES EXECUTIVE

The Health Services Executive program provides career opportunities to manage and lead organizations within the long-term care industry including nursing homes, residential care, assisted living, and home and community based services. The program provides the knowledge and skills required to obtain licensing as a Health Services Executive, which many states have recognized as the standard for long-term care administrators. The program has been approved by the Minnesota Board of Executives for Long Term Services and Supports allowing graduates to be eligible to become licensed as a Health Services Executive.

PROGRAM FEATURES

- The Health Services Executive program includes a variety of courses including medical terminology, nursing assistant training, population health, health and disease, leadership, health care policy, quality improvement, finance, regulatory management, strategic planning, social gerontology, and an internship.
- The program provides a foundation in nursing facilities, residential care, assisted living, and home and community based services using theory and experiential learning to advance the knowledge and skills necessary for career success, graduate education, and engaged citizenship.
- The program is designed to meet the needs of long-term care supports and services resulting in improved relationships and confidence in the knowledge and skills of our graduates. In addition, the program's close assignment with industry needs will provide an improved career pathway in long-term care.

INTERNSHIP

As part of the online coursework, students will be required to complete a 1,000-hour internship that consists of experiential learning and aspects of regulatory and leadership education. The internship will occur in the areas of skilled nursing homes, residential care and assisted living facilities, and home and community based services, all of which provide long-term care services and supports. A faculty member must approve the internship site and the necessary paperwork must be completed prior to commencing the internship.

CAREER OUTLOOK

According to the U.S. Bureau of Labor Statistics, the outlook for medical and health services managers, including long-term care administrators, continues to be very strong.
